This event offers a fun filled Saturday of art, crafts, pottery, excellent music, wine and delicious foods! For 2018, Financial Pathways is proud to be holding this event at Divine Llama Vineyards. Below you will find general information regarding this event, as well as a vendor application. General Information

The Crafty Llama Art, Craft and Vintage Market is a one-day event that takes place at the local Divine Llama Vineyards. The venue is nestled among five acres of vineyards and twenty acres of pasture land, features a tasting room for Divine Llama Vineyard's wines, llama, and hayrides. The event will have an array of vendors from North Carolina as well as food trucks and local music. The event will be held, rain or shine.

Event information

Event Date: November 3rd, 2018

Check in: Saturday November 3rd at 8am. Vendors must be unloaded by 10am and booth must be staged and ready by 10:30am.

Breakdown: Breakdown begins at 5pm on Saturday, November 3rd and must be cleared by 7pm.

To create the best experiences for our shoppers, late set-up and/or early break down is not permitted and could result in denial of participation in the future. If you feel that 2.5 hours is not sufficient to set up your booth, please discuss with Megan prior to the event.

Please encourage your guests to carpool as we expect a lot of traffic this day! In addition, there are 3 big rules that we need help getting to our guests: No outside alcohol is permitted, no smoking is allowed within 15 ft of the buildings and all animals must be on a lease. During the event, if you see any of this behavior, please report this behavior to Megan Thompson (336-413-2996).

Booths

All booths are 100 sq ft. (mostly 10 x 10 but some may vary) and it is highly recommended that you have a tent, as the event is rain or shine (tables are not provided). Multiple booths can be purchased for more space. **The rate for one booth is \$55.** There is no electricity available. We prefer only food vendors have generators, as they are loud and can be disruptive to your booth neighbor. Smoking is prohibited within the vendor area.

Marketing

The Crafty Llama Art, Craft and Vintage Market will heavily market the event across various platforms, including print and social media outlets.

Legal Disclaimer

All vendors participate at their own risk. The Crafty Llama Art, Craft and Vintage Market, Financial Pathways of the Piedmont and Divine Llama Vineyards disclaim all liability that may arise from a vendor's participation in the event. All vendors who set up a tent are required to have them sufficiently and safely anchored (25 lbs. per leg). Any vendor who fails to properly anchor his or her tent will now be allowed to sell at the event unless they are willing to take the tent down and sell without it. No vendor is allowed to bring in outside alcohol, or smoke within 15 ft of the building. Only animals on leashes are permitted at this event. Any violation of these rules will result in the vendor being asked to leave the event. Vendors are expected to communicate these rules in all publications concerning the event.

All vendors are required to man their own booth, collecting and reporting all taxes as necessary. Vendors are also responsible for obtaining any permits or licenses required to sell at the show. The Crafty Llama Art, Craft and Vintage Market, Financial Pathways of the Piedmont and Divine Llama Vineyards are not responsible for loss, theft, or damage to any property on-site before, during or after the show. Vendors will be held liable for any property damage by anyone in their party.

Vendor Application

Applications for The Crafty Llama Art, Craft and Vintage Market are due by Midnight October 12th, 2018. There is no application fee.
